Sinbad-Sadie Second Chance Rescue (SSSCR) Volunteer Agreement:

In consideration of this opportunity to volunteer, I agree to the following terms and conditions, intending to be legally bound by them:

1. I will abide by the mission, rules, regulations, policies, and programs of SSSCR while I am a volunteer.
2. If I stop being a volunteer for SSSCR for any reason or upon SSSCR's request at any time, I will promptly return SSSCR supplies, equipment, records, moneys, and other items in good, clean, condition.
3. I assume the risks of being bitten, scratched, injured or frightened by cats, kittens, dogs, and puppies (and any other animal species encountered) in connection with my volunteer work for SSSCR. SSSCR is not liable to me for any injuries, damages, liabilities, costs or expenses whatsoever which I might suffer or sustain in connection with the performance of my volunteer activities for SSSCR. I indemnify, defend, and hold SSSCR harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever sustained by any companion animal, family member, or guests to my home and/or property while performing volunteer duties for SSSCR.
4. I understand and agree that SSSCR may refuse volunteer applications for any reason.

5. If I shelter, provide foster care or boarding, or transport any of SSSCR's animals in my home, business or car (transport only), I consent to a visit by SSSCR representative periodically to observe the animals and their living conditions.
6. I understand that minors under the age of 18 must be accompanied at all times by a SSSCR approved volunteer over the age of 18 and I agree that, at no time, will a minor accompanying me on my volunteer duties be left alone with or in charge of a SSSCR animal.
7. I have accurately and truthfully completed this volunteer and application agreement.
8. Any modifications to this agreement must be in writing and signed by both parties. This agreement is binding upon SSSCR, myself and SSSCR's and my respective heirs, successors, assigns, executors, and person representatives.
